As we all prepare for back-to-school, we want to help support you and your children in whatever form their educational experience takes this year. In 2019, on average, families spent close to \$700 per student for school supplies. In addition, many schools also asked parents to

contribute up to \$100 per family for general use classroom materials. When combined with other childcare costs, many military families face difficult choices about whether to ensure their children are well supplied for school or whether to purchase other essential items for their family, including clothing and food. This year, the Hunt Heroes Foundation, in partnership with Operation Homefront, will distribute 1,850 backpacks filled with much-needed school supplies to military families at each of our communities. We are proud to be partnering with this well-respected national non-profit who last year provided backpacks to over 43,000 military children across the U.S. Watch for more information in the coming days about this effort and how you can apply to receive school supplies for your child. As we move ahead together and navigate these uncertain times, we remain committed to serving you and your families.

### **Amenities Update**

## Resident Guidelines Reminder of the Month - August 2020

### 8. PROPERTY POLICIES

#### 8.18 Noise/Quiet Hours

Quiet hours will be observed between the hours of 2200 and 0800 Sunday through Thursday and between 0100 and 0800 on Friday and Saturday. Outside of established quiet hours, Residents are required to control the volume of stereos, TV's and musical devices within their home so that they do not disturb the residents of other homes. Residents should be considerate of their neighbors since other Residents may have non-standard working hours or situations that can be adversely affected by noise emanating from outside their home. Noisy or disorderly conduct will NOT be tolerated at any time.

### 8.28 Soliciting

Soliciting is prohibited without written approval from MOODY FAMILY HOUSING. This includes fund raising, scout activities, school sales, etc. Residents are asked to request that unauthorized solicitors leave residential community grounds immediately, and then notify the neighborhood management office.

### 8.29 Speed Limit

Residents, Occupants, and their guests are required to abide by all traffic regulations set forth on the Installation and within the residential community. Speed limits within the community are limited to 15 miles per hour, unless otherwise posted and will be STRICTLY ENFORCED.









#### ASSUMPTION OF RISK and WAIVER OF LIABLITY RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Moody Family Housing ("Hunt") has put in place preventative measures to try to reduce the spread of COVID-19; however, Hunt cannot guarantee that you, your child(ren) or others will not become exposed to, or infected with, COVID-19. Further, utilizing the Hunt amenities, including, but not limited to, the fitness center, pools or playgrounds (collectively, "the Amenities") could increase the risk of contracting COVID-19.

By signing this agreement, I acknowledge on behalf of myself
individually, and as the parent(s)/guardian(s) of
for myself/ourselves, my/our heirs, executors, administrators, agents, invitees, users, participants, guests and
assigns (collectively, "the Users") the contagious nature of COVID-19 and voluntarily assume the risk that the
Users may be exposed to or infected by COVID-19 by using the Amenities and that such exposure or infection
may result in personal injury, illness, permanent disability, and/or death. I understand that the risk of becoming
exposed to or infected by COVID-19 by using the Amenities may result from the actions, omissions, or
negligence of myself and others, including, but not limited to, Hunt employees, or others.

In consideration of my/our use of the Amenities, I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself, my children or the Users, including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, relating to COVID-19, that I, my child(ren) or the Users may experience or incur in connection with our use of the Amenities ("Claims"). On my behalf, and on behalf of my children, and the Users, I hereby release, covenant not to sue, discharge, and hold harmless Hunt, its employees, agents, executives, assigns or representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Hunt, its employees, agents, executives, assigns or representatives, whether a COVID-19 infection occurs before, during, or after using any of the Amenities. I agree to indemnify Hunt and hold it harmless from and against any and all Claims arising out of our connected in any way with the use of the Amenities, whether such Claims are incurred or suffered by me/us, the Users, or any resident, invitee or guest in connection with Covid-19 and the use of the Amenities.

I/We acknowledge that I am/we are in good health and in proper physical conduction to use the Amenities. I/We further agree and warrant that if, at any time, I/we believe conditions to be unsafe, I/we will immediately cease using the Amenities.

This Agreement contains the entire agreement between and among the parties to this Agreement.

I/WE HAVE FULLY READ AND FULLY UNDERSTAND EVERYTHING WRITTEN ABOVE AND I/WE VOLUNTARILY SIGN THIS WAIVER AND RELEASE. I/WE FURTHER UNDERSTAND THAT BY SIGNING THIS WAIVER AND RELEASE I AM/WE ARE WAIVING VALUABLE LEGAL RIGHTS, INCLUDING, BUT NOT LIMITED TO, ANY CLAIMS ARISING FROM ANY NEGLIGENT ACT OR OMISSIONS OF HUNT THAT RELATES TO COVID-19 EXPOSURE AND/OR INFECTION.
